

QUALIFICATIONS FOR CANDIDATE FILING DECLARATION QUALIFICATIONS

Before the filing officer accepts any declaration of candidacy, the filing officer shall read to the candidate the constitutional and statutory requirements for candidacy, and the candidate shall state whether he/she fulfills the declaration of candidacy (Utah Code Section 20A-9-201,202)

LOCAL BOARD OF EDUCATION

Utah Code 20A-9-201, 20A-14-103, 20A-101.5

- U.S. Citizen
- Resident of the local school board district in which the member is seeking election for at least one year immediately preceding the date of the election.
- Maintain primary residence within the board district from which the member is elected or appointed.
- *Qualified voter in the district from where the person is chosen.
- **Not convicted of certain crimes.
- Never convicted of a grievous sexual offense against a child, as defined in Utah Code 76-1-601
- Pay filing fee of \$50.00

*A qualified voter (1) is a citizen of the United States; (2) is a resident of Utah; (3) will, on the date of that election; be at least 18 years old, and have been a resident of Utah for 30 days immediately before that election; (4) and has registered to vote.

**An individual convicted of certain crimes loses the right to hold office until convictions have been expunged OR the individual meets all of the following requirements: (1) 10 years have passed since the individual's most recent felony conviction, (2) The individual paid all court-ordered restitution and fines; and (3) the individual completed probation, granted parole, or completed the term of incarceration associated with the felony.

An individual convicted of an election related misdemeanor has restored their rights to hold office according to Utah Code 20A-2-101.3.



PLEDGE OF FAIR CAMPAIGN PRACTICES

Utah Code §20A-9-206

"These are the fundamental principles of fairness, honesty, and integrity which every candidate for public office in the state of Utah should follow. These principles are intended to guide the voter in choosing a candidate who is honest, upright, and truthfully motivated. It is the right of every citizen to know the character and the merits of the persons who will be permitted to exercise the right of suffrage.

THEREFORE,

I SHALL conduct my campaign openly and publicly, discussing the issues as I see them, presenting my record and policies with sincerity and frankness, and criticizing, without fear or favor, the record and policies of my opponents that I believe merit criticism.

I SHALL NOT use, nor shall I permit the use of, scurrilous attacks on any candidate or the candidate's immediate family. I shall not participate in, nor shall I permit the use of, defamation, libel, or slander against any candidate or the candidate's immediate family. I shall not participate in, nor shall I permit the use of, any other criticism of any candidate or the candidate's immediate family that I do not believe to be truthful, provable, and relevant to my campaign.

I SHALL NOT use, nor shall I permit the use of, any practice that tends to corrupt or undermine our American system of free elections, or that hinders or prevents the free expression of the will of the voters, including practices intended to hinder or prevent any eligible person from registering to vote or voting.

I SHALL NOT coerce election help or campaign contributions for myself or for any other candidate from my employees or volunteers.

I SHALL immediately and publicly repudiate support deriving from any individual or group which resorts, on behalf of my candidacy or in opposition to that of an opponent, to methods in violation of the letter or spirit of this pledge. I shall accept responsibility to take firm action against any subordinate who violates any provision of this pledge or the laws governing elections.

I SHALL defend and uphold the right of every qualified American voter to full and equal participation in the electoral process.

I, the undersigned, candidate for election to public office in the State of Utah, hereby voluntarily endorse, subscribe to, and solemnly pledge myself to conduct my campaign in accordance with the above principles and practices."
